EDITORIAL POLICY

Farmacia Hospitalaria (Farm Hosp) is the official scientific publication of the Spanish Society of Hospital Pharmacy (SEFH). It publishes articles on pharmacotherapy and the professional development of the specialty it represents.

Manuscripts submitted for consideration must be original, unpublished, and not under review by any other journal. Submission of a manuscript implies that: the work has not been previously published; it is not being considered for publication elsewhere; it is approved by all authors and, either explicitly or implicitly, by the relevant institutional authorities where the work was conducted. If accepted, it will not be published in any other media or language, including electronic formats, without written permission from the copyright holder. To verify originality and ensure the manuscript is not under simultaneous submission, all manuscripts will be screened using CrossCheck.

Manuscripts must follow the latest version of the recommendations of the International Committee of Medical Journal Editors (ICMJE) (available at: http://www.icmje.org) and comply with the guidelines outlined in this document. Failure to follow these instructions may result in the manuscript being returned to authors for correction before proceeding with the editorial process. Ethical principles regarding authorship and conflicts of interest must be observed. All opinions, statements, and potential errors contained in the articles are the sole responsibility of the authors.

All manuscripts will be reviewed by the journal's editorial board and will undergo a standardized double-blind peer review process conducted by experts selected by the editorial committee.

Farm Hosp publishes six regular issues per year (bimonthly), including original articles, brief originals, reviews, case reports, special articles, clinical protocols, consensus documents, clinical guidelines, letters to the editor, and editorials. In addition, special issues may be published on current topics in pharmacotherapy, pharmaceutical practice, or professional development.

The journal is Open Access, meaning its entire content is freely available without charge to users or their institutions. Users may read, download, copy, distribute, print, search, or link to the full texts of articles without prior permission from the publisher or the authors, in accordance with the BOAI definition of Open Access (https://www.budapestopenaccessinitiative.org). The journal is indexed in the Directory of Open Access Journals (DOAJ) (https://doaj.org/). Reuse of articles is permitted under the terms of the Creative Commons 4.0 license (CC BY-NC-ND). Any use under this license is subject to authorization by the SEFH, which holds the rights to the articles.

Farm Hosp does not charge submission or publication fees.

Upon acceptance, the copyright of published articles is transferred to *Farm Hosp* and, consequently, to the SEFH, which may reproduce them in part or in full without the need for express permission. By submitting a manuscript, authors agree to transfer, exclusively, the rights of publication, reproduction, distribution, translation, public communication, and modification of their work. They expressly authorize the SEFH to publish and distribute it under the licensing terms it considers most appropriate, including Copyright or Creative Commons. A copyright transfer letter must be submitted at the time of manuscript submission through the online manuscript management system (https://www.editorialmanager.com/farma).

The editorial committee may include published articles in national and international indexing services or databases as they deem appropriate.

Authors of accepted articles expressly authorize the SEFH to generate video summaries of their work using generative artificial intelligence tools. These videos may include summaries of the article

content, images, graphics, and other visual elements, as well as narrated voiceovers. Their purpose is scientific dissemination and promotion of the articles through digital platforms, social media, the journal website, and other academic and scientific media. Authors affirm that they hold the necessary rights to authorize this audiovisual adaptation. This authorization is granted free of charge, without geographical or time limitations, and may be revoked in writing to the editor, without affecting videos already produced or disseminated.

Personal data collected during the submission process will be processed in an automated file managed by the SEFH for the purpose of handling article publication. Unless otherwise stated, submission of an article implies the author's consent to publish their name, surname, professional address, and email in the journal and in the SEFH's annual summaries at https://www.the SEFH.es, for the purpose of identifying authorship and enabling communication with readers.

Authors are responsible for obtaining permission to partially reproduce any material (text, tables, or figures) from other publications. Permission must be obtained from both the original author and the publisher. In some cases, publication permission may also be required from the funding institution.

Farm Hosp was among the founding journals of the Granada Group, now known as the International Collaboration of Pharmacy Journal Editors (ICPJE). It adheres to the recommendations of the Granada Declaration: Improving the quality of publications in and advancing the paradigms of clinical and social pharmacy practice research: The Granada Statements (published in Farm Hosp). These journals publish high-quality, peer-reviewed content in health services research related to the medication-use process. This includes, but is not limited to, prescribing, preparation, dispensing, administration, adherence, evaluation, follow-up, and outcomes related to both prescription and over-the-counter medications. They promote the concept of pharmaceutical care aimed at optimizing medication use to achieve public health and patient-cantered goals. This process encompasses attitudes, perspectives, knowledge, and behaviours of all actors involved, including prescribers, pharmacists, pharmacy staff, other healthcare professionals, patients, and caregivers. Although these journals often include "pharmacy" in their title or description, they welcome research involving any stakeholder in the medication-use process, as well as evaluations of medications themselves or systems used to optimize their use. While the journals share common goals, each occupies a distinct niche and is best suited for specific types of manuscripts.

EDITORIAL PROCESS

Manuscripts submitted for consideration in *Farm Hosp* must be uploaded through the journal's electronic submission system: www.editorial-manager.com/farma/default.aspx. Submission instructions are detailed in the corresponding section of these guidelines. If the manuscript does not comply with the specific requirements for its article type, it will be returned to the authors for modification before entering the editorial process.

Once the manuscript meets the journal's editorial standards and is considered suitable for evaluation by the editorial leadership of *Farm Hosp*, it will be assigned to an Editor, who will appoint peer reviewers and initiate the peer review process. The Editor-in-Chief or any handling editor reserves the right to reject a manuscript before the peer review begins. Upon submission, the authors will receive an email with a reference number, which must be used in all communications with the editorial office and can be used to track the manuscript's status via the "Current Status" section in the author's account.

After undergoing the standardized double-blind peer review process (by experts designated by the editorial board), the Editor will send the anonymous reviewers' reports to the authors, together with a decision: acceptance, rejection, reconsideration with minor revisions, or reconsideration with major

revisions.

If revisions are requested, authors must submit a revised version of the manuscript with all changes clearly highlighted, along with a response letter addressing each of the reviewers' and editor's comments. If the authors disagree with any comment, they may provide a reasoned explanation in the response letter. If necessary, the revised manuscript will undergo a second round of review before a final editorial decision is made.

If the manuscript is deemed suitable for publication, acceptance will be confirmed. The editorial board reserves the right to reject manuscripts that are not considered appropriate, and to suggest any modifications they deem necessary. In all cases, the editorial board's decision is final.

Once the manuscript is accepted, the production process begins with the creation of a PDF proof in the original language of submission. This proof is sent to the corresponding author by email for review and correction via the journal's editorial platform. After the author approves the proof, it is reviewed by the editor, and upon final approval, the article is published online as an "ahead of print" version. The translation into the complementary language (Spanish or English) is then processed, following the same steps as the original version. Finally, the article is assigned to a specific issue of *Farm Hosp* according to editorial planning and scheduling.

ARTICLE TYPES AND LENGTH

Farm Hosp publishes the following types of articles:

Editorial. Editorials may be scientific or opinion pieces. They may include commentary on original articles published in the same issue, on current topics in hospital pharmacy or therapeutics in general, or on subjects that have recently generated debate. Editorials are typically commissioned by the editorial board, although authors may also submit proposals for consideration. In such cases, prior consultation with the editorial office is recommended.

Original. Reports of quantitative or qualitative research on any aspect of pharmacotherapy or the professional development of hospital pharmacy.

Brief Original. Research articles with the same characteristics as original articles, but which, due to their concise nature or specific focus, can be presented in a shorter format.

Review. Comprehensive reviews—preferably using systematic methodology, with or without meta-analysis—on relevant and up-to-date topics concerning pharmacotherapy or the professional development of hospital pharmacy.

Case Report. Manuscripts that describe new adverse drug reactions, novel drug interactions, paradoxical effects, atypical pharmacokinetics, assessments of treatment effectiveness, or other noteworthy findings based on a single case, which may be considered of therapeutic interest or innovation.

Letter to the Editor. Comments on articles previously published in the journal. Priority will be given to letters referring to articles published in the most recent issue. In such cases, the letter will be sent to the authors of the referenced article so they may exercise their right of reply if they wish.

Special Article. Articles providing an in-depth analysis of a current and specific topic, offering an updated and practical overview of subjects such as pharmaceutical practice models, healthcare policy, or educational matters. These articles are usually commissioned by the editorial board. Authors

interested in submitting a spontaneous contribution to this section should consult the editorial office in advance regarding the suitability and editorial requirements. All special articles are subject to editorial review.

Consensus Document and Clinical Guideline. Consensus statements and evidence-based clinical practice guidelines must be endorsed or promoted by the SEFH or recognized health authorities.

Protocol. Farm Hosp encourages the publication of research protocols from studies that have received approval from a Clinical Research Ethics Committee (CEIC) or a Research Ethics Committee on Medicinal Products (CEIM). Study results (full or partial) must not have been previously published or accepted for publication elsewhere. MANUSCRIPT PREPARATION GUIDELINES

Farm Hosp publishes articles in both Spanish and English. If an article is submitted in English, the Editor may request that the manuscript be professionally revised by a certified language editing service, which must provide a certificate of language quality regarding the language of the manuscript.

Manuscripts must be submitted in Microsoft Word format, using a 12-point font size, 1.5 line spacing throughout, 2 cm margins on all sides, and page numbers placed in the bottom right corner. Abbreviations should be avoided in the title and not used in the abstract. The first time an abbreviation appears in the text, it must be preceded by the full term. Units of measurement should follow the International System of Units (SI). For manuscripts written in Spanish, decimals should be indicated with a comma and thousands with a period. For manuscripts written in English, decimals should be indicated with a period and thousands with a comma.

The maximum word count for abstracts, main text, tables and figures, and references varies according to the type of article as shown below:

REFERENCES AND CITATION GUIDELINES

Farm Hosp follows the 11th edition of the American Medical Association (AMA) citation style: https://nwtc.libguides.com/c.php?g=49024&p=315498. Authors may use reference management software that supports the AMA 11th edition style (e.g., EndNote, Mendeley, Zotero), but they are responsible for ensuring that all references comply with the journal's formatting requirements.

References must be numbered consecutively in the order in which they first appear in the text. Once assigned, a reference number must remain consistent throughout the manuscript. Superscript numbers should be used without parentheses and placed after punctuation marks such as periods, commas, quotation marks, or closing parentheses. However, they must precede semicolons and colons. There should be no space between the last character or punctuation and the reference number. Use commas to separate multiple sources and hyphens to indicate a range of consecutive references.

All references cited in the text must appear in the reference list at the end of the manuscript, and all entries must be cited in the text, maintaining the same order. Most references should have been published within the past 10 years, and at least 30% should be from the last 5 years.

ETHICAL RESPONSIBILITIES

All submitted studies—including minimal-intervention observational studies, whether prospective or retrospective—involving human participants or animals must have been previously reviewed and approved by a Clinical Research Ethics Committee (CEIC), a Medicines Research Ethics Committee (CEICM), or a Research Ethics Committee (CEIM). Authors must confirm that the study adheres to the fundamental principles of the World Medical Association's Declaration of Helsinki, available at: https://www.wma.net/policies-post/wma-declaration-of-helsinki-ethical-principles-for-medical-research-involving-human-subjects

The corresponding author is responsible for safeguarding patients' right to privacy, by protecting their identity both in the writing of the manuscript and in any accompanying images. When applicable, the manuscript must state that data or images were obtained with the patient's prior written informed consent. These ethical safeguards must be clearly and explicitly described in the Methods section.

The publication of case reports or case series requires that patients provide written informed consent prior to submission of the manuscript, in order to safeguard patient confidentiality and autonomy. Authors must explicitly state in the manuscript that such consent has been obtained. The patient consent form should not be sent to the journal.

The patient information sheet and informed consent form must be prepared in accordance with the Committee on Publication Ethics (COPE) recommendations for obtaining patient consent prior to publication of case reports and case series: https://doi.org/10.24318/cope.2019.1.6

MANUSCRIPT SUBMISSION PROCESS

Manuscripts must be submitted electronically through the Editorial Manager platform, available at: https://www.editorialmanager.com/farma/default.aspx, which can also be accessed from the *Farm Hosp* website: https://www.revistafarmaciahospitalaria.es/en

The following documents must be uploaded to the system in Microsoft Word format:

1. Cover letter

The cover letter must be addressed to the Editorial Office of *Farm Hosp* and signed by all listed authors, including their national identification number (DNI or equivalent). It must formally request the evaluation of the manuscript for publication in *Farm Hosp*.

The cover letter must include the following:

- The title and type of article, subject to final classification by the journal's editorial board.
- The total word count of the abstracts (in Spanish and English) and of the main manuscript (excluding the title, abstract, keywords, tables, figures, and references).
- A clear statement that the manuscript has not been previously published and is not currently under review by any other journal or media outlet.
- Confirmation that the necessary permissions have been obtained for the reproduction of any
 previously published material (if applicable). These permissions will be requested by the
 editor during the review process and must be submitted through the platform together with
 any required revisions.

• Indication of whether the manuscript has been previously presented at a conference or scientific meeting, and, optionally, whether it has received any awards or recognitions.

2. First page

- <u>Title of the manuscript in Spanish and English</u>: The title must provide a detailed description
 of the content and include terms that, together with the abstract, will ensure accurate and
 specific electronic retrieval. It should include keywords aligned with *Medical Subject Headings* (MeSH) terminology. The title should be as concise as possible and limited to a
 single sentence (generally no more than 15 words). Avoid acronyms, codes, and uncommon
 symbols.
- <u>Authorship and affiliation</u>: Provide the full names of all authors (not abbreviated), using one or two surnames listed in the appropriate authorship order. On the following line, include the department or service, institution(s), city, and country. Do not include academic degrees or professional titles. It is recommended to define a "bibliographic surname" by using either a single surname or both surnames joined by a hyphen, to avoid confusion in bibliographic databases. Include the ORCID ID for each author.
- Corresponding author: Provide the name, surname, and email address.
- <u>Acknowledgments:</u> Acknowledgments should be made to individuals or institutions that clearly contributed to the work but do not meet the criteria for authorship. All persons mentioned must be informed of and approve their inclusion in this section. If Al was used to assist with manuscript writing, it must be disclosed in this section as well.
- <u>Funding:</u> Authors must disclose any financial or material support received for the study, including the funding agency, institution, or company, along with the project, grant, or contract numbers. If no external funding was received, please state: "*No funding*."
- <u>Conflicts of interest:</u> All manuscripts submitted to *Farm Hosp* must include a declaration of potential conflicts of interest for each listed author. Conflicts of interest may be professional, research-related, financial, or personal. Upon manuscript submission, authors must briefly declare whether any such conflicts exist. The editorial office may request that this declaration be expanded or clarified if deemed necessary. If no conflicts exist, authors must explicitly state: "No conflicts of interest."

This declaration is a mandatory requirement for all article types and must be completed in the "Funding and Conflicts of Interest" section of the authorship form to be submitted with the manuscript. Reference: http://www.icmje.org/conflicts-of-interest/

- Authorship declaration and copyright transfer: The uniform requirements for manuscript submission to scientific journals establish that authorship must be based on substantial contribution to all of the following:
 - Conception and design of the study, or data collection, or data analysis and interpretation.
 - o Drafting of the manuscript or critical revision with important intellectual input.
 - Approval of the final version for publication.

All of these conditions must be fulfilled. Sole involvement in funding acquisition, data collection, or statistical analysis does not constitute authorship, nor does general project

supervision. The corresponding author is responsible for ensuring that all listed individuals meet the authorship criteria and that no eligible contributor is excluded, in order to avoid scientific misconduct.

Each author's contribution will be disclosed at the end of the article under the CRedit (Contributor Roles Taxonomy) authorship statement.

Authors are encouraged to carefully review the list and order of authors before the initial submission. Any addition, removal, or reordering of authors must be requested prior to manuscript acceptance and requires editorial approval. The corresponding author must submit to the Editor:

- Detailed justification for the requested change
- Written confirmation (by email or letter) from all authors agreeing to the proposed change. In the case of addition or removal of an author, written consent from the affected author must also be included.

The editorial board will only consider authorship changes after acceptance under exceptional circumstances. If such changes are approved, publication will be temporarily suspended while the request is evaluated. If the manuscript has already been published online, the approved changes will be reflected in an erratum.

Requests to indicate equal contribution (e.g., joint first authors) may be considered if adequately justified and aligned with ICMJE authorship criteria. The request must be submitted in writing to the Editor, who will evaluate it and communicate the final decision to the authors.

There is no fixed limit on the number of authors for any article type published in *Farm Hosp*. However, group authorship may be considered for consensus documents, special articles, and protocols. In such cases, all members listed as authors must fully meet the authorship criteria. When submitting a manuscript with group authorship, the corresponding author must indicate the name of the group (if applicable) and clearly identify the members who are recognized as authors and bear responsibility for the work. Individual contributions must be described and may be published. All named signatories of the article will be indexed by MEDLINE as authors.

Group members who do not meet the authorship criteria must be acknowledged in the acknowledgments section or in an appendix, with their permission.

All listed authors on the manuscript must be included in the copyright transfer form. Upon submission, authors must complete and sign the form declaring that they have read and approved the manuscript and that they meet the authorship criteria.  <u>Ethical Responsibilities:</u> All authors must accept the responsibilities defined by the ICMJE, available at: http://www.icmje.org.

They must complete the "Ethical Responsibilities" section included in the standard form which must be signed and submitted with the manuscript. In addition, they must complete the publication and copyright transfer agreement (available at: <u>Guarantees and copyright assignment</u>), encompassing both the authorship declaration and copyright transfer within a single document.

3. Main manuscript

<u>Abstract:</u> All manuscripts must include an abstract in both Spanish and English. The abstract must be self-contained and should clearly summarize the essential points of the article. As abstracts are often the only substantial part of the article indexed in many electronic databases—and the only part freely accessible—authors must ensure that the abstract accurately reflects the article's content. The information in the abstract must be consistent with the main text. Authors must provide keywords.

Avoid abbreviations unless they are widely recognized. Use short sentences and avoid subordinate clauses. The abstract must be written in the past tense, except for the conclusions.

The abstract must provide the context or background of the study and state its purpose, the basic procedures (e.g., participant selection, study design, measurements, and analytical methods), the main findings (including specific effect sizes and their statistical and clinical significance, where applicable), and the main conclusions. It should emphasize the most novel and important aspects of the study or findings, acknowledge major limitations, and avoid overinterpretation of the results.

For original articles, brief originals, and reviews, the abstract must be structured and include the following sections: Objective, Method, Results, and Conclusions. In the case of protocols, the structured abstract must include: Introduction, Methods (including statistical and ethical considerations), and Discussion (including limitations).

 Keywords: Below the abstract, three to six keywords must be provided in both Spanish and English to identify the content of the manuscript for indexing and inclusion in databases. Editorials and letters to the editor are the only exceptions, which may or may not include keywords; if they do, they must be in both Spanish and English.

Keywords must correspond to the *Medical Subject Headings (MeSH)* terms recommended by the U.S. National Library of Medicine, available at: ncbi.nlm.nih.gov/mesh

Main body of the article

- <u>Introduction:</u> The introduction should be concise and strictly focussed. It must aim to provide readers with the current context of the topic under study and justify the need for the work being presented. It is advisable to frame the problem with up-to-date data. Only essential references should be cited, selected based on their relevance and currency in relation to the study's objectives. The introduction must not include any data or conclusions from the study itself. The final paragraph should clearly state the rationale of the study.
- Methods: This section should describe the setting where the research was conducted, the time frame or duration, characteristics of the study population, selection criteria, and techniques employed. It must precisely explain how the study was carried out, including the type of design, inclusion and exclusion criteria, treatment protocols, interventions performed, and statistical analysis. Sufficient detail must be provided to allow the study to be replicated based on the information included. Any drugs or chemical substances used must be clearly identified, including their dosage and route of administration.

It is recommended to include a figure or flowchart outlining the study phases, such as

inclusion and exclusion criteria, participant selection, interventions and measurements (if applicable), and number of patients who completed the study.

If the study involves human participants, it must state that approval was obtained from a CEIC, CEICM, or CEIM. This approval is mandatory for the manuscript to proceed through the editorial process. The protocol registration number and date of the ethics committee decision must be provided.

- Results: This section must describe the findings obtained through the application of the materials and methods, detailing both positive and negative results. The presentation must be descriptive, concise, and clear, avoiding any interpretation of the data. Results may be included in the text or presented as tables or figures, but data should not be duplicated in both formats. Appropriate statistical indicators or uncertainty should be included (e.g., confidence intervals and/or p-values). Only the most relevant findings, aligned with the study objective, should be emphasized or summarized.
- <u>Discussion</u>: This section must interpret the results, emphasising the novel and significant aspects of the study and the conclusions that follow from them. The discussion must address the following points:
 - The most relevant findings.
 - Comparison with similar publications and differences with those.
 - The interpretation and practical implications of the results.
 - The authors' critical perspective.
 - The limitations or methodological issues that may exist, and the reasons why the results are still considered valid.
 - o Recommendations and considerations for future research.
 - If conclusions are included, these must be exclusively derived from the study findings.

In brief original articles and case reports, the discussion must be short and focused on the most notable aspects of the study. It should not become a literature review, nor should it repeat points already made in the introduction. Results should not be restated. Unsupported assertions and claims not backed by data must be avoided.

- Tables: Tables should be presented on separate pages and must include:
 - o Table number in Arabic numerals, cited in the text in sequential order.
 - o Table title at the top, with any abbreviations or acronyms explained at the bottom.
 - Each column must have a heading. The content must be self-explanatory, and the data presented must not be repeated in the text or in other tables or figures.

The journal accepts tables of up to one printed page in *Farm Hosp*. Longer tables should preferably be submitted as supplementary material.

• <u>Figures</u>: Figures comprise all non-tabular material (e.g., morphology images, algorithms, histograms, graphs, etc.) and must be cited in the text in sequential order. They must be submitted in colour, with high resolution and image quality. Photographs of people must ensure subjects are not identifiable. All figures must be accompanied by a legend placed below the figure, numbered according to their order of appearance.

 <u>Contribution to the Scientific Literature:</u> All articles must include a brief paragraph summarizing the manuscript's contribution, providing readers with a general overview of the most relevant content. This text must not be a verbatim copy of the abstract and must not include abbreviations.

It is recommended to include the following information:

- A first paragraph (maximum 100 characters) describing the study's contribution to existing knowledge.
- A second paragraph (maximum 100 characters) outlining the implications of the results for clinical practice, research, healthcare policy, or hospital pharmacy in general.
- <u>Declaration use of generative artificial intelligence:</u> This type of statement must be included at the end of the manuscript, before the references.
 - Declaration: During the preparation of this work, the author(s) used [NAME TOOL/SERVICE] for [REASON]. After using this tool/service, the author(s) reviewed and edited the content as needed, assuming full responsibility for the content of the publication.
- References: References must be formatted in accordance with the citation guidelines outlined above.
